Chapter 147 – SURVEILLANCE TECHNOLOGY AND DATA PROTECTION

Section 147-7. – ~~Effective date.~~ Public-facing dashboard.

~~This chapter shall take effect on January 1, 2021.~~

The police department shall publish and maintain a dashboard on the city’s website regarding the departments use of surveillance technology permitted pursuant to this chapter.

The dashboard shall contain data regarding (i) each request for use of facial recognition technology; (ii) surveillance technology databases used pursuant to written agreement; and (iii) a link to NOPD’s dashboards reporting disciplinary violations of this chapter. The data required by this section shall be searchable and downloadable in a comma-separated value or similar spreadsheet format and shall include the following information:

(a) Data regarding requests for use of facial recognition technology.

- (1) The name and employee ID number of the officer making the request;
- (2) The name and employee ID number of the supervisor who approved the request;
- (3) The date on which the request was granted;
- (4) The enumerated crime(s) justifying the use;
- (5) The age, gender, and race of the suspect;
- (6) The accompanying NOPD item numbers;
- (7) Whether the use of facial recognition technology resulted in a match;  
and
- (8) Whether the use of facial recognition technology resulted in an arrest, including the associated enumerated crimes.

(b) Data regarding surveillance technology databases used pursuant to written agreement.

- (1) The name, manufacturer and version of software used;
- (2) Statistical data and any reports regarding the accuracy and efficiency of any software used as a surveillance technology; and
- (3) The source of any databases or information which is used by the technology to provide identifications or solutions.

**(c) Data regarding disciplinary violations of this chapter.**

**(1) Appointing authority of city employee disciplined for violating this chapter.**

**(2) Nature of the violation, including citation to the violated section of this chapter.**
