**BY: COUNCILMEMBER HARRIS (BY REQUEST)**

**AN ORDINANCE** to amend and reordain Sections 70-84 and 70-87 of the Code of the City of New Orleans, relative to budget reporting requirements; and otherwise to provide with respect thereto.

**WHEREAS**, the staffing report required under Section 70-84 of the City Code was instituted to enable the Council to monitor departmental vacancies that were being budgeted but never filled; and

**WHEREAS**, councilmembers are now able to monitor departmental personnel spending through personnel projections data without the need for the staffing report; and

**WHEREAS**, the full-time equivalent summary report continues to serve a useful purpose and should be retained; and

**WHEREAS**, the fund balance report required under Section 70-87 of the City Code currently includes all City funds, including funds with no financial activity and in the most recent reporting period, 89 of 170 funds included in the report had no transactions; and

**WHEREAS**, limiting the fund balance report to active funds and providing account descriptions upon request rather than monthly would reduce the report’s size by approximately half while preserving the Council’s ability to obtain this information; **NOW THEREFORE**

1           **SECTION 1. THE COUNCIL OF THE CITY OF NEW ORLEANS HEREBY**  
2 **ORDAINS**, That Sections 70-84 and 70-87 of the Code of the City of New Orleans are  
3 amended to read as follows:

26 board of review committee, a report on the fund balances for all operating funds appropriated  
27 by the city, unless a fund was inactive during the preceding year, in which case the inactive  
28 fund may be excluded from the report. Information included in such monthly reports shall  
29 contain audited data; if audited data is unavailable, the report shall contain unaudited data.

30 Information included in such reports shall contain, at minimum, the following information for  
31 each city fund:

On or before June 1, 2022, and on On a monthly basis thereafter, the department of finance shall present to the budget, audit, and board of review committee, a summary report on full-time equivalents for all operating funds currently appropriated by the city. Information included in such monthly summary reports shall contain, at minimum, the following information for each city agency:

- (1) — Fund
- (3) — Classification code
- (4) — Classification name
- (5) — Number of filled full time equivalents
- (6) — Total personal services cost of filled full time equivalents
- (7) — Number of vacant full time equivalents
- (8) — Total personal services cost of vacant full time equivalents
- (1) Total budgeted full-time equivalents by agency**
- (2) Total filled full-time equivalents by agency**
- (3) Total full-time equivalents vacancy number by agency**
- (4) Total full-time equivalents vacancy rate by agency**

This report shall encompass:

- (i) Any fund created by chapter 70 of the Code of the City of New Orleans;
- (ii) Any other fund created by any other provision of this Code or the Charter; and
- (iii) Any other fund maintained by the department of finance.

On or before June 1, 2022, and on On a monthly basis thereafter, the department of finance shall present to the budget, audit, and board of review committee a report on the fund balances for all operating funds appropriated by the city, unless a fund was inactive during the preceding year, in which case the inactive fund may be excluded from the report. Information included in such monthly reports shall contain audited data; if audited data is unavailable, the report shall contain unaudited data. Information included in such reports shall contain, at minimum, the following information for each city fund:
