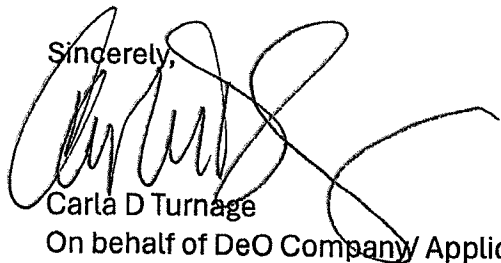

Dear Ovella Enterprises, LLC:

This letter confirms the actions of the New Orleans Historic District Landmarks Commission at its meeting of Wednesday, June 3, 2026, concerning your application for the following work: Demolition of a Contributing rated raised basement, single-family residential building to grade.

At that time the Commission voted to:

Deny the application for demolition, as the raised bungalow retains much of its character-defining features. Aside from deflection in the flooring, the structure appears to be in good condition. However, The non-contributing rear addition may be demolished without adversely affecting the historic character of the building.

Furthermore, the HDLC encourages the owner to not only make the minor repairs to secure the building envelope but also implores them to ensure the windows remain closed to prevent unnecessary exposure to the elements, which is actively contributing to continued deterioration and decay.

If you wish to appeal the Commission's decision to the City Council, you must submit a written request for appeal to both the HDLC and the Clerk of Council at clerkofcouncil@nola.gov. Alternatively, written requests may be delivered to the Clerk of Council, City Hall, Room 1E09, New Orleans, LA 70112. **All requests must be submitted within ten (10) calendar days of the Commission meeting.** Please be sure to include a copy of this letter with your request.
