**BRIEF DESCRIPTION:**

An amendment to Ordinance Calendar No. 35,387 to revise the Housing Trust Fund Advisory Committee appointments to include one from the City Council Quality of Life Committee Chair and another from the City Council Budget, Audit, and Board of Review Committee; to update the appointment schedule during municipal election years; and to change the quarterly and annual reporting due dates.

**AMENDMENT:**

1. On page 4, delete lines 65 and 66 and insert the following in lieu thereof:
  - (2) One appointee of the city council quality of life committee chair;
2. On page 4, delete lines 68 through 73 and insert the following in lieu thereof:
  - (4) One appointee of the city council budget, audit, and board of review committee chair;
  - (5) One appointee of the city council president, with such appointee having lived experience being unhoused or living in a low-income or other affordable housing unit;
3. On page 4, line 77, delete the phrase “for approval”.
4. On page 4, line 77, delete the word “December.” and insert the following in lieu thereof:

December, for council approval at the first regular meeting in the following January, except for years when a mayor and council are inaugurated in January, in which case the council may consider

appointments at the first regular meeting following the council's inauguration.

5. On page 5, line 79, delete the phrase "January 1" and insert "on the date of council approval" in lieu thereof.
6. On page 5, line 87, delete the phrase "January, April, and July" and insert "April, July, and December" in lieu thereof.
7. On page 6, line 108, delete the phrase "first regular council meeting in October" and insert "last regular council meeting in September" in lieu thereof.

**AN ORDINANCE** to amend and reordain Sections 70-415.339 through 70-415.342 of Division 54 of Chapter 70, Article III of the Code of the City of New Orleans, relative to the Housing Trust Fund to clarify appropriations, processes, and oversight of the Fund, and otherwise to provide with respect thereto.

**SECTION 1. THE COUNCIL OF THE CITY OF NEW ORLEANS HEREBY ORDAINS**, That sections 70-415.339 through 70-415.342 of the Code of the City of New Orleans, Louisiana are amended to read as follows:

**“CHAPTER 70 – FINANCE**

**DIVISION 54. – NEW ORLEANS HOUSING TRUST FUND**

**Sec. 70-415.339. - Funding and purpose.**

To ensure the availability of affordable housing for low- to moderate-income residents within the City, all funds maintained in the Housing Trust Fund shall be used exclusively for the following purposes, hereinafter referred to as “exclusive fund purposes”:

- (a) Creating and preserving affordable homeownership opportunities, including but not limited to owner-occupied rehabilitation; development subsidies; homebuyer assistance; soft second assistance; foreclosure prevention; home weatherization, such as fortified roofing; and shared equity strategies.
- (b) Expanding the supply of affordable rental housing units, including but not limited to affordable multifamily housing financing; strategic investment, acquisition, disposition, or lease of property; and technical support.

- (c) Preserving affordable rental housing units to prevent the future displacement of residents, including but not limited to rental rehabilitation.

**Sec. 70-415.340. - Restrictions on fund.**

- (a) Moneys deposited into the fund shall remain therein until spent for the exclusive fund purposes, except as provided in this section. The funds may not be transferred into the general fund or any other funds.
- (b) Portions of the annual appropriation deposited into the fund may be reserved as follows:
  - (1) No more than five percent shall be reserved for “rainy day” funds, to be used exclusively in the event of a declared emergency.
  - (2) No more than ten percent may be reserved for personnel or professional services to support the administration of the fund.
  - (3) The percentage of the annual appropriation remaining after the foregoing reservations are made shall be reserved as “program funds”, to be used for the exclusive fund purposes, with a minimum of forty-five percent of the program funds reserved equally among the three exclusive fund purposes. The remaining fifty-five percent of the program funds shall be further allocated among the three exclusive fund purposes, as recommended by the advisory committee and approved by the council, pursuant to section 70-415.342.
- (c) Except for expenses from reserves permitted under paragraph (b)(2) above, all funds must be used in accordance with the federal Fair Housing Act’s obligation to affirmatively further fair housing, provided at 42 U.S.C. section 3601, *et seq.*
- (d) All fund expenditures and allocations shall prioritize those projects that provide climate resilient elements, creative and leveraged funding opportunities, and depth and longevity of affordability terms.

**Sec. 70-415.341. - Administration of fund.**

The director of the department of finance shall administer and maintain the fund in an interest-bearing account, with any interest accruing to the benefit of and to become part of the fund. However, nothing herein shall preclude the city from entering into an agreement with another party or parties to administer some or all of the fund, in accordance with the provisions of this division,

with any interest accruing to the benefit of and to become part of the fund. Such party, whether the director of the department of finance or one or more other parties, is hereinafter referred to as the “fund administrator”.

**Sec. 70-415.342. - Housing trust fund advisory committee.**

- (a) *Creation and purpose.* No money shall be appropriated from the housing trust fund in any year unless and until the city council appoints or reappoints a housing trust fund advisory committee. In accordance with sections 3-127 and 4-104 of the charter, the advisory committee is limited to counseling and advising the city council and the mayor concerning appropriations from the fund.
- (b) *Composition.* The advisory committee shall have a total of seven members, all of whom shall be electors of and domiciled in the city and shall possess experience in one or more of the following areas: architecture and preservation, community development, community and housing development finance, economic development, fair housing, populations with special needs, smart growth, sustainable development, and local and regional housing and neighborhood data. The city council shall ensure that all areas of expertise and experience are represented in the membership of the advisory committee. The advisory committee shall consist of the following members:
  - (1) One appointee of the mayor;
  - (2) ~~One appointee of the city council budget, audit, and board of review committee chair;~~ **One appointee of the city council quality of life committee chair;**
  - (3) One appointee of the city council community development committee chair;
  - (4) ~~One appointee of the city council president, with such appointee having lived experience being unhoused or living in a low income or other affordable housing unit;~~ **One appointee of the city council budget, audit, and board of review committee chair;**
  - (5) ~~One appointee of the city council president, with such appointee being an employee or representative of a community land trust organization that owns immovable property within Orleans Parish;~~ **One appointee of the city council president, with**

**such appointee having lived experience being unhoused or living in a low-income or other affordable housing unit;**

- (6) One appointee of the Louisiana Fair Housing Action Center; and
  - (7) One appointee of Southeast Louisiana Legal Services.
- (c) *Appointment terms.* Appointment nominations shall be submitted by the appointing body to the city council ~~for approval no later than the second council meeting in December.~~ **December, for council approval at the first regular meeting in the following January, except for years when a mayor and council are inaugurated in January, in which case the council may consider appointments at the first regular meeting following the council's inauguration.** The terms of each member who has been appointed, and of the committee, shall commence ~~January 1~~ **on the date of council approval** of each year and end on December 31 of the same year. Each advisory committee member may be reappointed. Any vacancy on the advisory committee shall be filled in the manner of the initial term, and such appointments shall be for the remainder of the unexpired term. Members of the advisory committee shall adhere to the requirements of the city code of ethics and the state code of governmental ethics.
- (d) *Committee duties.*
- (1) *Quarterly reporting.* The housing trust fund advisory committee shall submit a quarterly report to the city council for its receipt at the first regular council meetings scheduled in ~~January, April, and July~~ **April, July, and December**. Such reports may be prepared by the advisory committee or the fund administrator(s) and reviewed by the advisory committee prior to submission to the city council. Each quarterly report must include, at a minimum, the following performance measures:
    - (i) the balance of the fund;
    - (ii) all revenues;
    - (iii) all expenditures, including program spending per exclusive fund purpose by dollar and by percentage;
    - (iv) the number of households assisted;
    - (v) the number of affordable rental units created;

- (vi) the number of affordable rental units preserved;
- (vii) the number of affordable homeownership units (e.g., houses or condominiums) created;
- (viii) the number of affordable homeownership units preserved;
- (ix) the development status for multifamily housing projects receiving financing assistance; and
- (x) any other relevant performance data as specified in any applicable cooperative endeavor agreement, notice of funding availability, or otherwise, as requested by the council.

(2) *Annual reporting.* In coordination with the fund administrator, the advisory committee shall prepare and submit an annual report to the city council for its receipt at the ~~first regular council meeting in October~~ **last regular council meeting in September**. The annual report must provide the following:

- (i) a detailed accounting of all fund revenues and expenditures for the preceding year;
- (ii) year-long data on the quarterly performance measures required pursuant to paragraph (d)(1) for the preceding year;
- (iii) a recommended budget for the upcoming fiscal year, specifying the program funds to be allocated among the three exclusive fund purposes and in accordance with this section; and
- (iv) an implementation plan for all recommended expenditures.

The recommended budget must include a minimum of fifteen percent of the program funds assigned to each exclusive fund purpose, with the remaining fifty-five percent of the program funds allocated among one or more of the exclusive fund purposes, in accordance with residents' housing needs.

(e) *Fund budget and implementation plan.*

- (1) Within forty-five days of receipt, the city council shall approve the budget and implementation plan for incorporation in the city's operating budget ordinances.

- (2) The council may either approve, by motion, the budget and implementation plan as initially recommended, or it may direct, by motion, the advisory committee to reconsider the initial recommendation with specified modifications.
  - (3) Within ten days of the council motion directing the advisory committee to reconsider the initial recommendation, the advisory committee shall submit to the council its recommended budget and implementation plan, as reconsidered and as modified.
  - (4) If the council fails to act on the budget and implementation plan on or before the second regular council meeting in November, whether it be as initially recommended or as reconsidered and modified, the budget and implementation plan as last submitted by the advisory committee shall be deemed adopted for incorporation into the city's operating budget ordinances. Nothing herein shall prohibit the council from thereafter amending the operating budget ordinance.
- (f) *Staffing.* The office of community development shall furnish such services as may be needed by the advisory committee.”
