**AN ORDINANCE** to rename a portion of West Robert E. Lee Boulevard, bounded by Hammond Highway, Regent Street, and Pontchartrain Boulevard, to Zephyr Court; and otherwise to provide with respect thereto.

**WHEREAS**, in accordance with Section 146-760 of the Code of the City of New Orleans, a request to rename a portion of West Robert E. Lee Boulevard, bounded by Hammond Highway, Regent Street, and Pontchartrain Boulevard, to Zephyr Court, was initiated via Motion Number M-26-6 of the Council of the City of New Orleans on January 8, 2026, and directed the City Planning Commission to consider the renaming; and

**WHEREAS**, the City Planning Commission held a public hearing on this proposed change and recommended approval of the name change (**Street Name Change No. 1/26**); and

**WHEREAS**, the recommendation of the City Planning Commission was approved, and the changes were deemed necessary and in the best interest of the City of New Orleans and were granted approval, as stated in Motion Number M-26-127 of the Council of the City of New Orleans on March 26, 2026; **NOW THEREFORE**

1           **SECTION 1. THE COUNCIL OF THE CITY OF NEW ORLEANS HEREBY**  
2   **ORDAINS**, That West Robert E. Lee Boulevard, bounded by Hammond Highway, Regent Street, and  
3   Pontchartrain Boulevard, shall henceforth be named Zephyr Court.

4           **SECTION 2.** The Department of Public Works shall signify all changes imposed by this  
5   ordinance though the installation of new signage.

**SECTION 3.** The staff of the City Planning Commission shall provide written notice of the approval to the Mayor's Office, the Department of Public Works, the New Orleans Police Department, the New Orleans Fire Department, the Department of Finance, the Department of Safety and Permits, New Orleans EMS, the Sewerage and Water Board, the Orleans Parish Communications District, the Orleans Parish Assessor, the Clerks of Criminal and Civil District Court for the Parish of Orleans, the United States Postal Service, the private utilities for the City, the designated steward of the City's electronically maintained repository of street names, any entity requested in writing by the Mayor or the City Council, and all other appropriate departments and/or agencies of the renaming.

**SECTION 4.** The Department of Public Works and the Geographic Information Systems Division of the Office of Information Technology and Innovation shall implement this change within 90 days of the adoption of this ordinance.
