As one of the many dancer who travel from across the country to visit New Orleans and dance on Bourbon Street. I am writing in support of motion 26-52 and oppose motions 26-7 and 26-8.

New Orleans is a popular destination for dancers, because of its lively nightlife and club culture. While visiting, I, and my fellow dancers, stay for longer than the average tourist, which means we spend more on local business and pay more in tourist taxes. We, like the clubs themselves, are good for the economy. Limiting the number of clubs on Bourbon Street means limiting our ability to contribute. It also endangers local dancers, as their safety depends on their ability to go to a different club if they feel unsafe or uncomfortable with management at their current club. Our safety depends on our ability to choose where we work and no one should lose their livelihood because they are trying to escape mistreatment.

I understand that I am not a New Orleans voter; however, as a dancer, even and maybe, especially, a visiting dancer, I feel obligated to share my input and stand with my coworkers in opposing the zoning restrictions.
