1. On page 2, line 28, after “2017,”, add the following “, and again on November 15, 2025, a fee **not to exceed \$200.00**”
2. On page 4, line 68, after “November 21,2015,” replace the text and add “again on November 3,2020, and again on November 15,2025, a flat fee”
3. On page 4, line 69, after “**not exceeding**”, replace “**one hundred dollars (\$175)**” with the following “**two hundred dollars (\$200)**”.
4. On page 5, line 95, after “2010,”, replace with the following, “again on April 28, 2018, and again on November 15,2025, a flat fee **not to exceed six hundred (\$600)**”
5. On page 5, line 97-98, after “amount of”, replace “**four hundred fifty dollars (\$450.00)**” with the following, “**five hundred twenty-five dollars (\$525)**”
6. On page 8, line 162-163, after “February 1, 2014,” replace “and again on November 18, 2017, a flat fee **not to exceed seven hundred dollars (\$700)**” with the following, “again on November 18,2017, and again on November 15,2025, a flat fee **not to exceed one thousand two hundred dollars (\$1200)**”
7. On page 10, line 225, after “**(R)**”, add the following, “**Lake Vista Crime Prevention District**. In accordance with Act 67 of the 2002 First Extraordinary Session of the Louisiana Legislature, and as amended by Act 417 of the 2012 regular session of the Louisiana Legislature (R.S. 33:9091.5),and as further amended by Act 306 of the 2025

regular session of the Louisiana Legislature (R.S. 33:9091.5) and as approved by the voters of the Lake Vista Crime Prevention District voting in a referendum on November 6, 2012, and as subsequently reapproved by the voters of the Lake Vista Crime Prevention District voting in a referendum on November 8, 2016, again on November 3, 2020 , and again on May 3,2025, a fee **in the amount of not to exceed four hundred dollars (\$400.00)** is hereby set on each improved or unimproved single and two-family residential parcel and each multiple-dwelling or apartment parcel located within the Lake Vista Crime Prevention District. A flat fee in the amount of **two hundred dollars (\$220.00)** is hereby levied for the year **2026** on each improved or unimproved single and two-family residential and each multiple-dwelling or apartment parcel located within Lake Vista Crime Prevention District.

8. On page 16, line 357, after “(DD)” add the following, “**Tall Timbers Crime Prevention and Improvement District**. In accordance with the provisions of Act 419 of the 2024 Regular Session of the Louisiana Legislature (R.S. 33:9091.28), and as approved by the voters of Tall Timbers Crime Prevention and Improvement District voting in a referendum on November 15,2025, a parcel fee **to not exceed two hundred thirty dollars (\$230)** for the first two years, for the third and any subsequent year, the fee shall not exceed two hundred fifty dollars. A special annual fee in the amount of **\$230** is hereby levied for the year **2026** on each parcel located within the Tall Timbers Crime Prevention and Improvement District.
9. On page 17, line 32, add a line with the following, “**k. Lake Vista Crime Prevention District**”

10. On page 17, line 37, add a line with the following, “**q. Tall Timbers Crime Prevention**”
