AN ORDINANCE to amend Section 10-125 of the City Code to require that certain information appear on an alcoholic beverage outlet permit; and otherwise to provide with respect thereto.

1 **SECTION 1. THE COUNCIL OF THE CITY OF NEW ORLEANS HEREBY**
2 **ORDAINS**, That Section 10-125 of the Code of the City of New Orleans, Louisiana is amended
3 to read as follows:

4 **“Sec. 10-125. – Permits to be displayed.**

5 (a) All permits issued under the provisions of this chapter shall be displayed in a conspicuous
6 place at all times on the premises. If the establishment's ability to sell alcoholic beverages
7 is granted by ordinance from the city council, the operating provisos relative to that use
8 shall also be displayed. Failure to display the aforementioned shall constitute a violation of
9 this chapter.

10 (b) All permits issued under the provisions of this chapter shall include the following
11 information:

12 (1) The name of the permit holder;

13 (2) The location of the permitted business;

14 (3) The account number and permit number of the permitted business;

- 15 (4) The type of permit: low alcoholic content, high alcoholic content, or both;
- 16 (5) Whether the permit is for alcoholic beverage consumption on premise or off-premise;
- 17 (6) The issuance date of the permit;
- 18 (7) The expiration date of the permit;
- 19 (8) The date the permit renewal application is due;
- 20 (9) A statement that the permit must be displayed in a conspicuous location; and
- 21 (10) A statement that the permit is not transferable, assignable, or heritable and is only for
- 22 the business and address listed thereon.”

Sec. 10-125. – Permits to be displayed.

(a) All permits issued under the provisions of this chapter shall be displayed in a conspicuous place at all times on the premises. If the establishment's ability to sell alcoholic beverages is granted by ordinance from the city council, the operating provisos relative to that use shall also be displayed. Failure to display the aforementioned shall constitute a violation of this chapter.

(b) All permits issued under the provisions of this chapter shall include the following information:

- (1) The name of the permit holder;**
- (2) The location of the permitted business;**
- (3) The account number and permit number of the permitted business;**
- (4) The type of permit: low alcoholic content, high alcoholic content, or both;**
- (5) Whether the permit is for alcoholic beverage consumption on premise or off-premise;**
- (6) The issuance date of the permit;**
- (7) The expiration date of the permit;**
- (8) The date the permit renewal application is due;**
- (9) A statement that the permit must be displayed in a conspicuous location; and**
- (10) A statement that the permit is not transferable, assignable, or heritable and is only for the business and address listed thereon.”**
