**Applicant:** 641 Baronne, LLC

**Request:** Conditional use to permit a hotel in a CBD-5 Urban Core Neighborhood Lower Intensity Mixed-Use District

**Property description:** Square 258, two (2) undesignated lots, in the First Municipal District, bounded by O’Keefe Avenue, Lafayette Street, Baronne Street, and Girod Street

**Municipal address(es):** 613 Baronne Street

### Description

#### Site and Building Conditions

The subject property, located on Baronne Street in the CBD-5 Urban Core Neighborhood Lower Intensity Mixed-Use District (**See Figure 1**), is currently developed as offices. The site consists of two (2) undesignated lots, each measuring 48 feet by 128 feet and operating as one (1) parcel. The site is occupied by an existing 3-story commercial structure that is approximately 45 feet tall (**See Figure 1**). The lot area totals 12,288 square feet, and the existing structure totals 28,104 square feet. The structure, originally built in 1910, then renovated in 1999, extends to the Baronne Street (front) property line.



**Proposed Conditions**




**Figure 4: Proposed Elevations – Baronne Street**

The proposed 4-story hotel includes two commercial tenant spaces on the first floor, along with five (5) guest suites (See Figure 2). The second and third stories comprise ten suites each, while the added fourth floor (or penthouse) has eight (8) suites and an amenity space (See Figure 3). The total number of guest rooms is 33, made up of suites with one to three bedrooms each. Applicants propose maintaining the existing structure and adding a new 9,100-square-foot penthouse that will match current conditions (See Figure 4). The primary entrance will remain on Baronne.

The rear of the property faces a surface parking lot on O’Keefe Avenue and will also remain as-is, with repairs to the existing storefronts as needed (**See Figure 5**). According to the applicant’s NPP summary, the building is currently only partially leased to local businesses, none of whom operate outside of standard business hours. The applicant also indicated that the new hotel use will meet all city requirements for a hotel. This includes having a lobby that will be staffed at all times. There is no parking requirement, and the application does not indicate any on-site parking.

**Reason for Commission Review**

Per **Article 17, Section 17.3.A (Table 17-1: Permitted and Conditional Uses)**, a hotel is deemed a conditional use in the CBD-5 Urban Core Neighborhood Lower Intensity Mixed-Use District. The City Planning Commission is required to make a recommendation on all conditional use applications prior to City Council action, in accordance with **Article 4, Section 4.3.D.3 – Action by the City Planning Commission** of the Comprehensive Zoning Ordinance.

### Comments related to design

- =The proposal is limited in its design impact, as the structure is to be mostly retained in its current form, save the addition of the penthouse level. The limited changes that are proposed will have to be approved by the Historic District Landmarks Commission, as the site is within the Lafayette Square local historic district.

### Anticipated impact on surrounding land uses

Hotels are generally permitted uses in the Central Business District but have been classified as a conditional use in the CBD-5 district since 2015. In 2022, the City Council adopted use standards to guide the decision-making process for new hotel applications. These standards which are contained in **Article 20, Section 22.3.XXX** of the CZO seeks to generally limit them to one per blockface; limit hotels to relatively smaller size (i.e., 100 or fewer rooms/suites; discourage residential-to-hotel conversions; and encourage the replacement of parking lots. This proposal is to be viewed favorably under three of the four standards: it would be the only one on the blockface, is under 100 rooms/suites, and is not a residential conversion. As the building is existing, the proposal does not involve the development of a parking lot.

In terms of land use impacts, the proposed 33-suite hotel development is not expected to greatly increase traffic to and from the site. Rather, it is expected to provide a more consistent flow of residents and visitors than the existing office use. Staff believes the concentration of visitors over office workers will actually decrease the number of vehicles and increase the amount of foot traffic in the neighborhood. The site is also located on the dedicated bike path on Baronne Street, promoting cycling to and from the site. Depending on the anticipated commercial tenants, more neighborhood-serving amenities might be provided.

### Evaluation of approval standards

The City Planning Commission recommendation and the City Council decision on applications for a conditional use shall, on the basis of all information submitted, evaluate the impact of the conditional use on and the compatibility of the use with surrounding properties and neighborhoods to ensure the appropriateness of the use at a particular location. The Commission and Council are required to specifically consider the extent to which the proposed use meets the approval standards contained in **Article 4, Section 4.3.F Approval Standards** of the Comprehensive Zoning Ordinance. In this section, the staff evaluates the application using those standards.

### ***The proposed use at the specified location is consistent with the policies embodied in the adopted Master Plan.***

This standard is met. The Home Rule Charter of the City of New Orleans requires all land use actions to be consistent with the Master Plan. A land use action is consistent with the Plan for the 21<sup>st</sup> Century, commonly known as the Master Plan, if it furthers, or at least does not interfere with, the goals, policies, and is compatible with the proposed future uses, densities, and intensities designated in the Land Use Element of the Plan. “Chapter 13: Land Use Plan” of the Master Plan designates on the Future Land Use Map (FLUM) of the petitioned site as “Mixed Use Downtown Core Neighborhood.” The goal, range of uses, and development character for that designation are copied below.

## **MIXED USE DOWNTOWN CORE NEIGHBORHOOD**

**Goal:** Encourage and support a compact, walkable, transit-oriented, mixed-use neighborhood at the core of the city.

**Range of Uses:** A mix of residential, office, commercial, hotel, retail, and service uses. Agricultural, stormwater management, and supporting public recreational and community facilities are allowed. Transit and transportation facilities are allowed.

**Development Character:** The scale of new development will vary depending on location, with taller development generally encouraged along the edges of the CBD and new development that is sensitive to the scale of the neighborhood encouraged within the interior of the area. Incorporate risk reduction and adaptation strategies in the built environment.

A mix of residential, commercial, and hotel uses is identified within the range of uses allowable in a Mixed-Use Downtown Core Neighborhood. Although the design of the existing structure is somewhat different from other historic buildings in the CBD, it remains sensitive to the scale of the neighborhood, particularly in regard to height, which will remain under the existing limit. Accordingly, the development proposal is consistent with the goals of the Mixed-Use Downtown Core Neighborhood future land use designation.

***The proposed use is consistent with the general purpose and intent of the applicable zoning district regulations.***

This standard is met. The site is located within a CBD-5 Urban Core Neighborhood Lower Intensity Mixed-Use District. The purpose of the CBD-5 Urban Core Neighborhood Lower Intensity Mixed-Use District is to provide for a downtown neighborhood environment through a mix of housing types and supporting residential services alongside commercial uses conveniently situated with respect to employment opportunities. The subject site would provide well-placed employment opportunities through its commercial uses and does not diminish the housing stock of the neighborhood. The above-referenced criteria in **Article 20, Section 22.3.XXX** clarify when hotels/motels in the CBD-5 district are appropriate. The proposed use meets all applicable criteria.

***The proposed use meets all standards specifically applicable to the use as set forth in Article 20 and all environmental performance standards of Section 21.3.***

Yes. The proposed use meets the standards set forth in **Article 20, Section 22.3.XXX** as well as the environmental performance standards of **Article 21, Section 21.3**. Further, the design standards discussed above clarify that these standards are met or will be met with the adoption of provisos suggested by the staff.

***The proposed use is compatible with and preserves the character and integrity of adjacent development and neighborhoods and, as required by the particular circumstances, includes improvements or modifications either on-site or within the public right-of-way to mitigate development-related adverse impacts.***

This standard is met. The proposed use would continue to operate as a commercial use towards the edge of the CBD-5 District, making it consistent with the character and integrity of the immediate surrounding area. The site is situated away from the more-solidly residential portion of the District,

and is surrounded by uses that serve both residents and visitors. This block has recently seen some improvements with newer developments, and the hotel along with its commercial tenants should complement them.

***Any variance of zoning standards meets the approval standards of Section 4.6.F.***

Not applicable. This request does not necessitate any variance of zoning standards.

***The proposed use is not materially detrimental to the public health, safety, and welfare, or results in material damage or prejudice to other property in the vicinity.***

This standard is met. The proposal would maintain a commercial use and increase foot traffic at more hours. Staff recommended provisos would address potential adverse impacts. In addition, the use complements the existing low intensity mixed use character in the area.

**Staff Recommendation**

The staff recommends **APPROVAL** of Zoning Docket 043/25 subject to four (4) provisos:

1. The lobby of the proposed hotel must comply with the definition of Customary Lodging Services, in accordance with **Chapter 26** of the Comprehensive Zoning Ordinance. The plans submitted for final approval must indicate a dedicated lobby area as required by the definition of Customary Lodging Services provided in **Chapter 26** of the Comprehensive Zoning Ordinance.
2. The plans submitted to the City Planning Commission for final approval shall indicate the installation of at least 4 short-term bicycle parking spaces as set forth in **Article 22, Section 22.4.A (Table 22-1)** and **Article 22, Section 22.6** of the Comprehensive Zoning Ordinance. The design of bicycle parking spaces shall comply with the requirements as set forth in **Article 22, Section 22.9** of the Comprehensive Zoning Ordinance. When submitting plans to the City Planning Commission for final approval, the applicant shall provide the City Planning Commission with documentation of all required approvals from the Department of Public Works for any bicycle spaces located in the public right-of-way.

Failure to complete the conditional use process by properly recording plans within a one-year time period or failure to request an administrative extension as provided for in **Article 4, Section 4.3H** of the Comprehensive Zoning Ordinance will void the conditional use approval.

CITY PLANNING COMMISSION MEETING (August 26, 2025)

The staff summarized the application and presented its recommendation for approval. The applicant spoke in support of the application as well. Staff answered Commissioner Joshi-Gupta’s question about lobby hours, stating that it is required to be open 24 hours. Commissioner Joshi-Gupta made a motion for approval and Commissioner Stewart seconded. The motion approved unanimously.

Motion:

BE IT MOVED BY THE CITY PLANNING COMMISSION THAT ZONING DOCKET 043/25 IS HEREBY RECOMMENDED FOR APPROVAL SUBJECT TO FOUR (4) PROVISOS. BE IT FURTHER MOVED THAT THE EXECUTIVE DIRECTOR IS HEREBY AUTHORIZED TO NOTIFY THE CITY COUNCIL OF SAID ACTION.

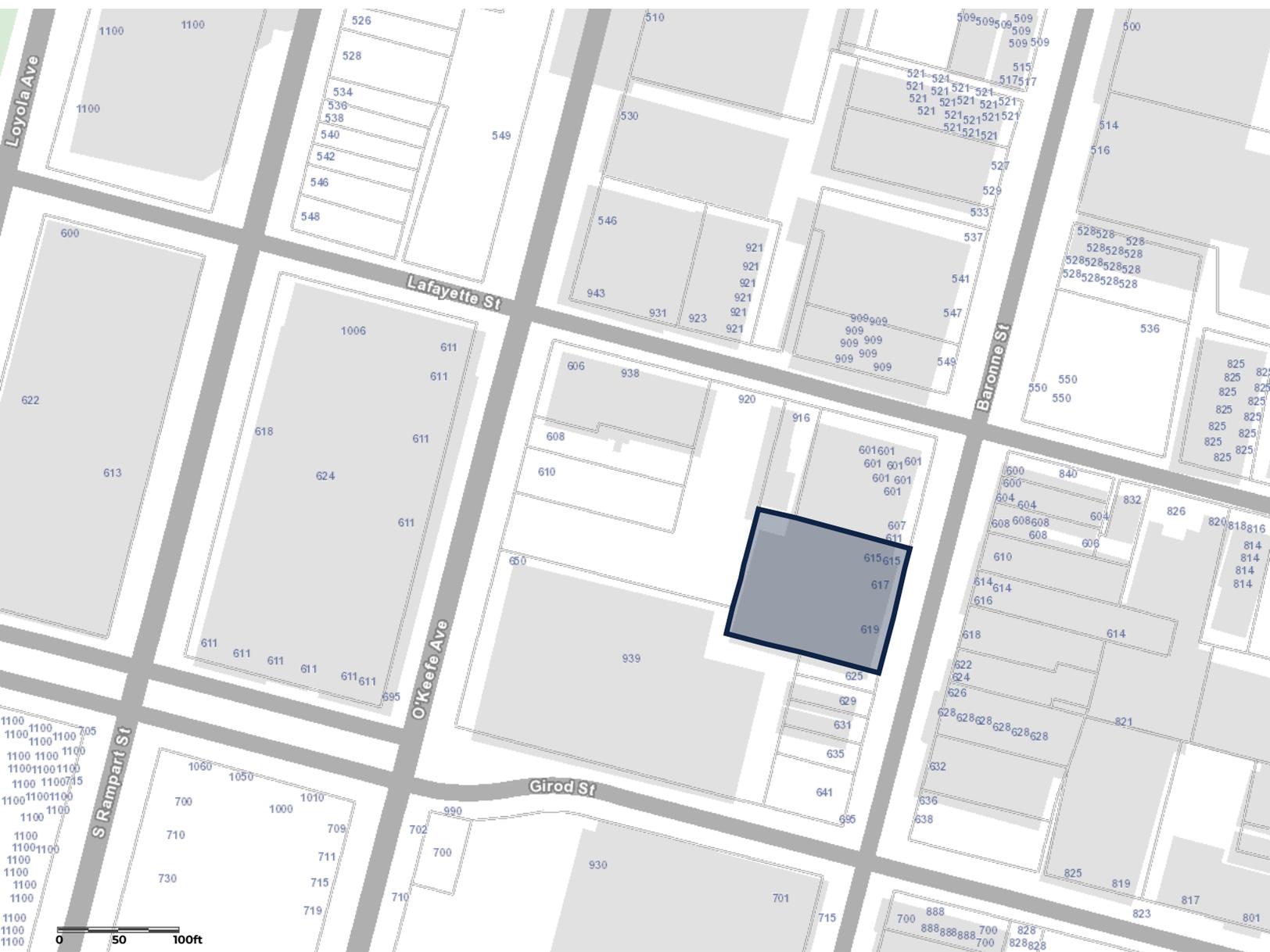

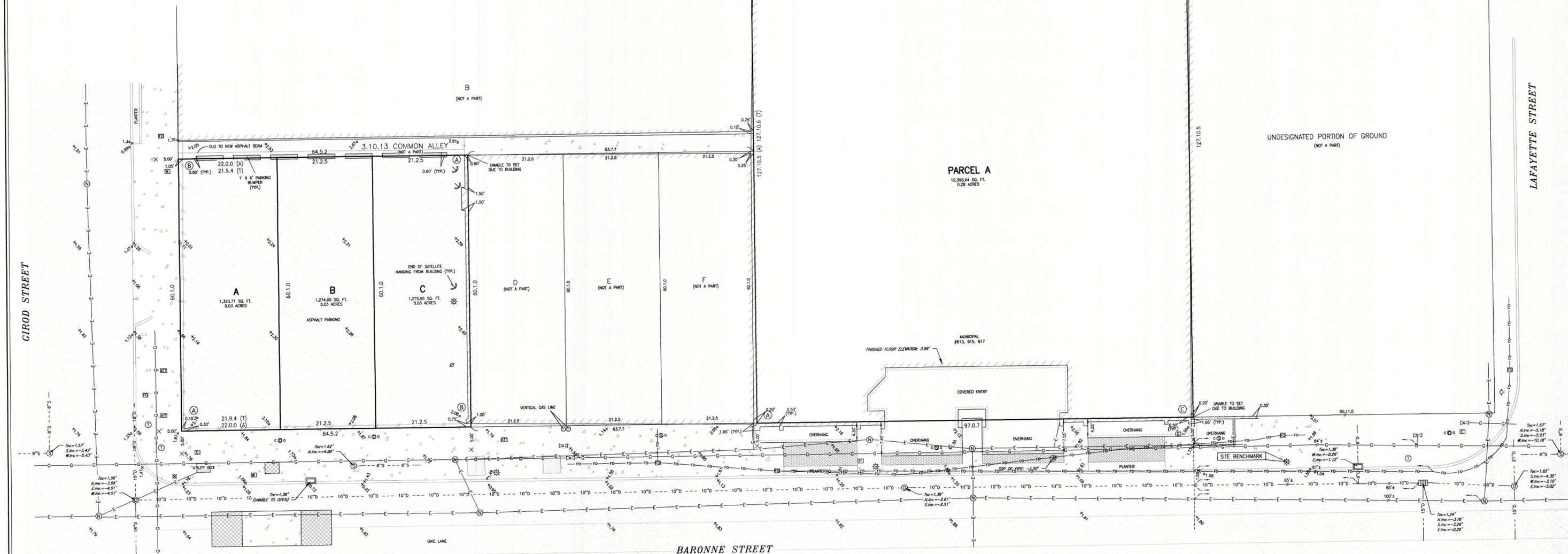

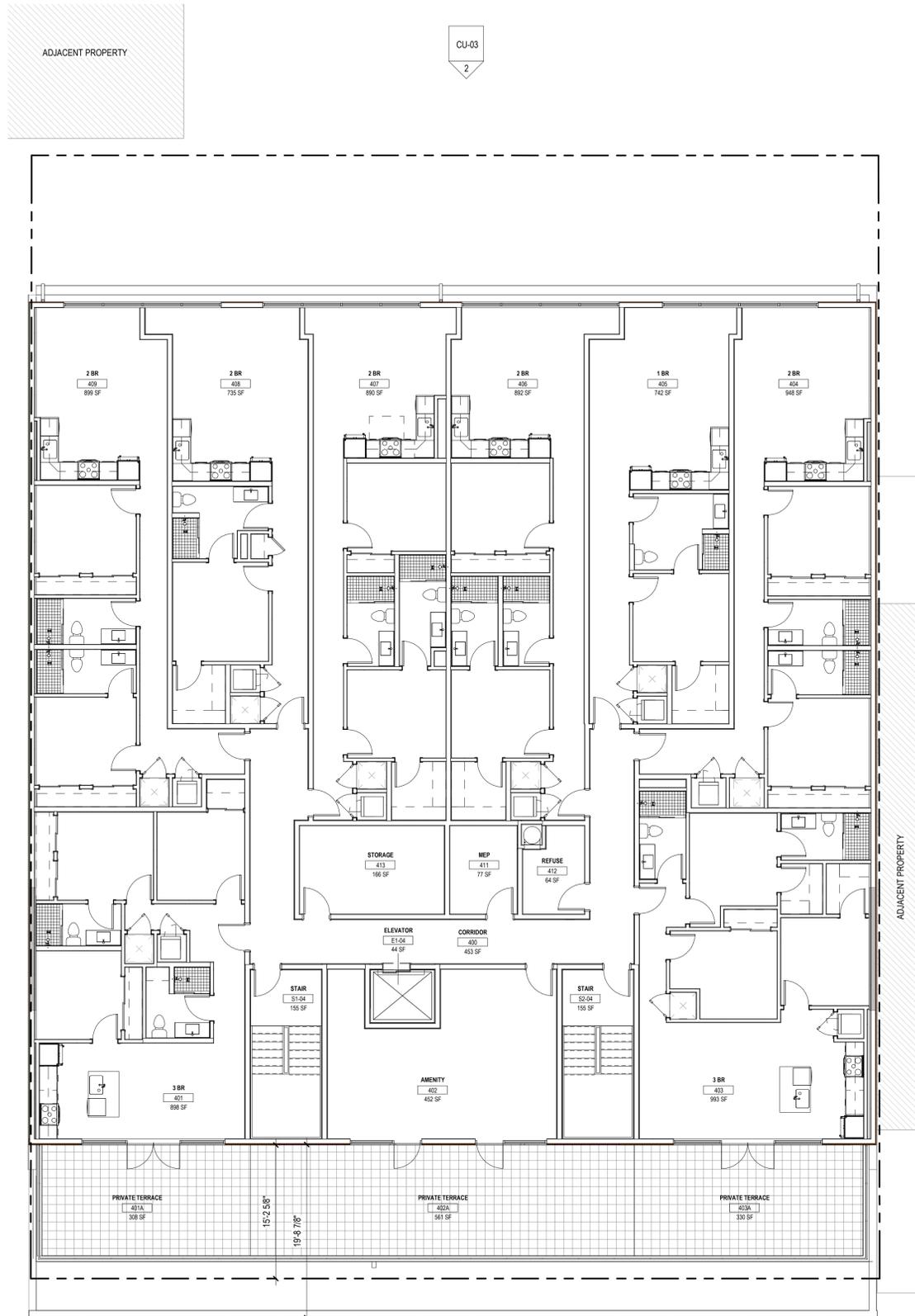

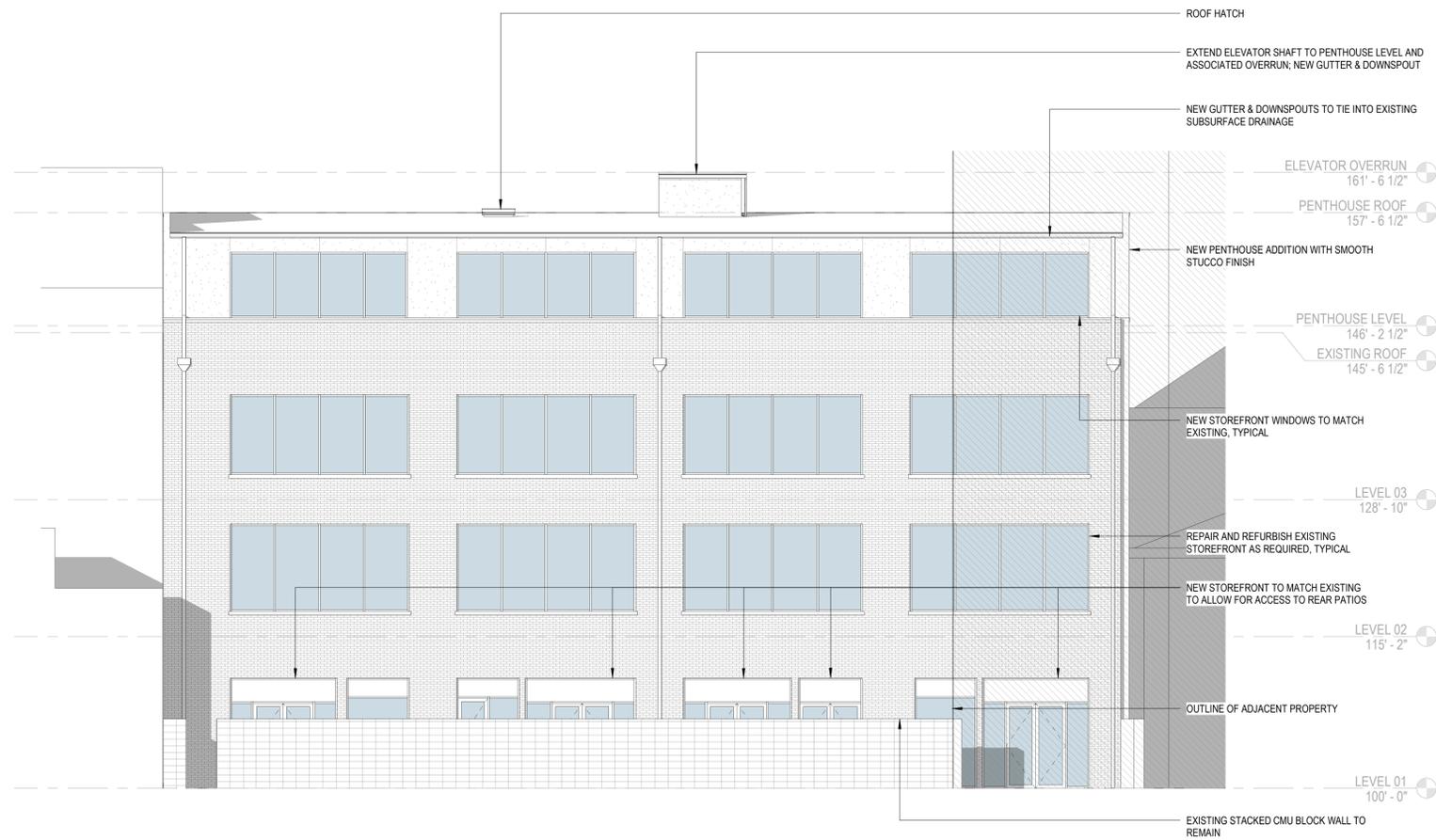

### Overview:

This report provides results of the implementation of the Neighborhood Participation Program for the property located at 615 Baronne Street in the middle of the lakeside block between Lafayette and Girod Streets. The applicant intends to file an application requesting a hotel be permitted in CBD-5 where it's a conditional use. This report provides a summary of contacts with neighbors who either contacted me via phone or attended our NPP meeting in person. The sign-in sheet and other materials related to our NPP are attached.

### Neighborhood Meeting

Neighbors and other interested parties were invited to discuss the applicant's proposal on July 26, 2025 at 6:00 pm at the office of AQ Studios, 1100 Poydras Street, Suite 3550, New Orleans, LA 70163.

### Correspondence and Telephone Calls

June 12, 2025 – Meeting notices mailed to the city-provided NPP contact list and emailed to neighborhood associations and the district councilmember

June 24, 2025 – Discussed proposal with neighbor, Linda Novak via phone.

June 26, 2025 – Discussed proposal with neighbor and Lafayette Square Neighborhood Association President, Michael Duplantier via phone.

### Results

1300+ persons/addresses were invited to the NPP meeting based on the city-provided NPP contact list

None of the attendees opted to write on the provided comment cards

Concerns, issues, and problems expressed by meeting attendees and those who reached out via phone:

- Waterproofing with adjacent properties
- Vibration due to construction
- Lack of awnings at terrace doors and whether sliders would be more appropriate than paired swinging doors
- Impacts of construction on access to adjacent buildings, particularly due to the current street closure of O'Keefe Avenue between Girod and Lafayette Streets
- The unappealing aesthetics of the Brutalist-style front façade
- Project timeline, including construction start and duration
- Rear façade appears to need brick repairs and concern about the building's structural integrity
- How to deter unhoused population from congregating under the front entry
- Trash removal
- Parking
- Hotel operation vs. a short-term rental

- AQ Studios will provide waterproofing details to the city as part of our permit application for review by the Historic District Landmarks Commission and Safety & Permits. The new penthouse walls will be flashed appropriately so no water intrusion occurs to adjacent properties.
- There should be limited vibration during construction as no additional piles will be required for the penthouse addition. The contractor is responsible for monitoring appropriate vibration levels during construction.
- We are currently exploring the addition of awnings as this was also a comment that was made by the Architectural Review Committee. Awnings are not required at exterior doors to prevent water intrusion.
- The contractor will apply for permits that require any temporary street closures, which will be reviewed and approved by the city prior to issuance. The intent is to limit the impact of our construction on our neighbors.
- The project timeline is dependent on the various regulatory bodies that are reviewing our applications, including the City Planning Commission, Historic District Landmarks Commission, Safety and Permits, State Fire Marshal, and State Historic Preservation Office. The construction start date will depend on how long these reviews take. AQ Studios is happy to update interested parties on our permitting progress. We also noted that interested neighbors can sign up for notifications from the city through NoticeMe.
- The rear façade brick will be evaluated during construction and repaired as required to maintain its integrity. It is non-structural. The concrete structure of the building is sound.
- The building is currently only partially leased to local businesses, none of whom operate outside of standard business hours. The new hotel use will provide more foot traffic during various times of the day, which will help with deterring people from congregating at the front entry. The hotel management will also help keep the area free of unwanted visitors. Improved lighting underneath the covered entry is also something we are exploring as part of our renovation.
- There is a refuse room on each floor of the building and trash pick-up will be private. Trash will not be stored in cans on the street but rather will be wheeled out at the time of pick up and returned to its location within the building.
- There is no intent to operate this building as a commercial short-term rental. The development will meet all city requirements for a hotel.

Concerns, issues, and problems that will not be addressed and why:

- Brutalist architecture may not be every person's taste, but we are pursuing historic tax credits, which require the façade be restored.
- Parking is not required in CBD-5, so we will not be providing on-site parking. There are various parking lots and garages nearby that hotel guests can utilize, as well as public transportation and ride shares.

- (d) to grant a promissory note in the amount of \$1,680,000.00, payable to Lender, and a Multiple Indebtedness Mortgage in the form of a Louisiana authentic act executed by 641 Baronne LLC in favor of Lender, securing its loan in the principal amount of \$1,680,000.00, with the maximum amount of indebtedness limited to \$50,000,000.00;
- (e) to grant collateral security for all or any part of any indebtedness or other obligations, covenants, or agreements ("Indebtedness") of the Company, in favor of Lender, and
- (f) otherwise to enter into any agreements, covenants or obligations regarding any or all of the Indebtedness and/or the collateral security therefor, all upon such terms and conditions as the Member may in his sole discretion consider appropriate; and in connection with the granting of any such collateral, to encumber, mortgage, pledge or grant a security interest on or in any property, rights or interests whatsoever of the Company, whether movable or immovable, whether corporeal or incorporeal, including but not limited to all or any items of equipment, inventory and accounts receivable, all upon such terms and conditions as the said Member may in his sole discretion consider appropriate.

3. In connection therewith, Member is further authorized and empowered:

- (a) to execute such documents and instruments as Member may in his sole discretion consider appropriate in order to effectuate any of the matters described herein, any or all of which may contain such terms and provisions as Member may in his sole discretion consider appropriate, including but not limited to a pact de non alienando, a due on sale clause, a confession of judgment, and other customary Louisiana acquisition, disposition, or security clauses, and which documents and instruments may include but are not limited to one or more promissory notes, loan agreements, security agreements, pledges, financing statements, settlement statements, cross-collateralization agreements, cross-default agreements, mortgages, conditional or collateral assignments, guaranties, agreements of subordination, acknowledgments, ratifications, guarantees, agreements for sale, acts of sale, bills of sale, other instruments of conveyance or disposition, leases, partnership documents, corporate documents, limited liability company documents, assignments, receipts, or affidavits; and
- (b) generally to do any and all other acts that the said Member may in his sole discretion consider appropriate in order to effectuate any of the matters

described herein, all upon such terms and conditions as the said Member may in his sole discretion consider appropriate, and all pursuant to such documents and instruments, containing such clauses and provisions, as the said Member may in his sole discretion consider appropriate.

4. The power and authority of Member as provided above has not been limited, restricted or abrogated in any way by any action of the Company.

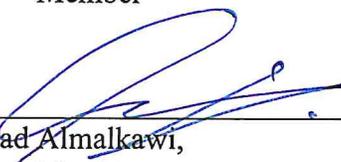
