Re: Appeal of the HDLC’s decision of approval for roof demolition of 7801–7803 Zimpel

To the Clerk of Council:

I am appealing the decision of approval by the N.O. HDLC of Dec. 3, 2025, for the application by developer Ravi Doddamani to camelback the contributing-rated, one-story, two-family residential building at 7801–7803 Zimpel through a roof demolition of over 50% (specifically, 55.9%).¹ As required, the HDLC’s decision letter is attached to this email (as “Decision”).

My appeal is addressed to the City Council in its capacity to exercise broad discretionary powers over HDLC demolition decisions.

Basis of the appeal

The HDLC describes the demolition of historic resources within the local Historic Districts as a “drastic action.”² And yet the camel-backing of smaller historic houses has unfortunately become routine; and applications for roof demolitions are regularly approved by the HDLC.

In this respect it might seem inequitable to refuse the new owners the right to camelback the modest shotgun at 7801–7803 Zimpel. In addition, it is also a drastic action to intervene in the use and enjoyment of private property.

And yet it is well known that Mr. Doddamani’s usual development practice (from 2014 to the present day) is to convert historic houses (or to build new construction) for exclusive use as transient housing marketed to university students (D2Ds) in the University Area, Uptown, and Broadmoor neighborhoods.³

Co-incidentally, a zoning violation may already be detected on the renovation plans.⁴ Three (3) full bathrooms are proposed—two (2) full bathrooms on the first floor (with an abundance of double fixtures) and the third (3) full bathroom on the second floor. This is a clear conflict with the amended University Area Overlay’s prohibition on more than 2.5 bathrooms for investment properties:

Any increase in bathrooms where the total number is more than two full and one half (2.5) per dwelling unit shall be prohibited in this overlay, as determined by the Department of Safety and Permits. ([CZO Art. 18.30.B.4](#))

Administrative history

Other considerations concerning the development of 7801 Zimpel are as follows.


- The property was purchased in an off-market sale on 11/10/25 from the succession of Gertrude Gillin in a cash sale for \$145,000, which is less than half the assessed fair value—in 2024, 2025, and 2026 (uncertified)—of 7801–7803 Zimpel, i.e., \$315,000. (See Exh. 6.)
- On 11/12/25, an application was filed for the interior demolition of the property; and Permit #25-31717-DEMI issued on 11/17/25. (See Exh. 8.) On information and belief, no demolition has occurred to date; and a dumpster is currently (12/15/25) parked on Burdette Street without a permit.
- The primary façade demolition had been part of the [original 12/3/25 Agenda](#) for 7801 Zimpel.⁵ Yet it was withdrawn before the 12/3/25 hearing. Explaining the reason for the withdrawal, Plans Examiner Dennis Murphy stated in the HDLC results letter of 12/4/25 that “the extent of the proposed partial façade demolition was miscalculated.” The letter informs the owners of the need to return to the HDLC on 1/7/25 if the proposal cannot be revised to exclude additional historic fabric. (No response has been registered to date.) Although Mr. Murphy attributes the demolition miscalculation to a “Staff error,” it’s my opinion that the developer or his contractor misrepresented the facade in a line drawing submitted to the HDLC for review.⁶

Conclusion

Despite the recent efforts of Tulane University to regulate the density of the student population in the University Area, developers continue to purchase and convert local properties, transforming the historic character of the neighborhood and removing long-term options from the housing market. In addition, as I attempt to prove in my ongoing BZA appeals of D2D renovation work permits, DSP continues to issue all D2D work permits to dorm developers without modification.

In the best interest of the neighborhood, which is already saturated with private student dorms, I respectfully request that the City Council exercise its discretion and overturn the decision of approval by the HDLC in re 7801–7803 Zimpel (roof demolition).

This letter confirms the actions of the New Orleans Historic District Landmarks Commission at its meeting Wednesday, December 3, 2025, concerning your application for the following work: Demolition of more than 50% of the roof structure at a Contributing rated, one-story, two-family residential building for construction of a new camelback addition.

At that time the Commission voted to:

Approve the application for partial roof demolition. Please submit one set of stamped, final detailed drawings. Following review, we will contact you regarding any errors, omissions, or changes. All drawings should be submitted to HDLC Staff via email. Once approved, these drawings will then be transmitted internally to Safety & Permits for their review and permitting. As such, it is important that the final drawings are sufficient for review by both Departments. Keep in mind that only the amount of demolition indicated in the HDLC approved drawings is authorized. Please contact me directly should existing conditions necessitate review of additional demolition or re-framing work. Demolishing additional square footage without the proper approvals can result in costly delays and fines.

Please note that, due to a Staff error, the extent of the proposed partial façade demolition was miscalculated and was not included in this Commission request. Because this portion of the work does require Commission approval, you will need to either revise the proposal to retain more of the historic building materials at the front elevation, or the application will need to return for additional Commission review and approval at the next available meeting on Wednesday, January 7th, 2025. Please contact HDLC Staff at your earliest convenience to discuss potential alternative façade revisions and the next steps in the HDLC review process.

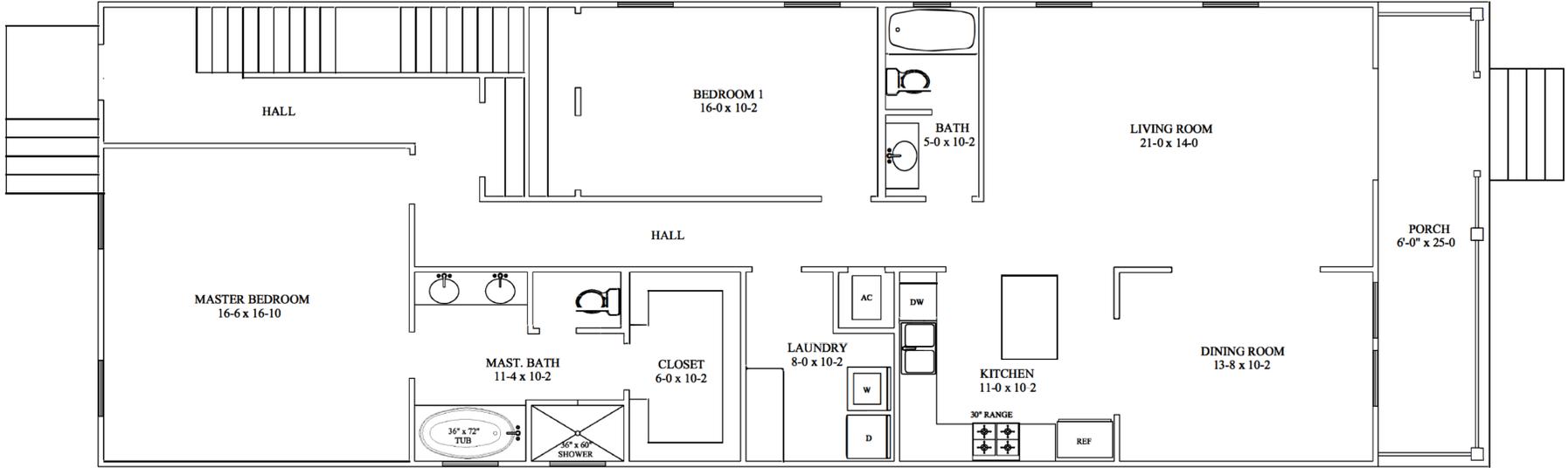
