WHEREAS, In the Election held on **May 16, 2026**, pursuant to **Resolution No. R-25-568**, as corrected, (**Clarifying and Amending Resolution No. M-25-557**) adopted on **November 5, 2025**, the number of votes cast **FOR** and **AGAINST** the **CASTLE MANOR IMPROVEMENT DISTRICT PROPOSITION** have been canvassed and compiled and the results thereof transferred to the compilation sheets attached hereto and made a part hereof; **NOW THEREFORE**

BE IT FURTHER MOVED, That the actual cost of this election, as determined by the Louisiana Secretary of State, based upon the provisions of Title 18, Chapter 8A of the Louisiana Revised Statutes and actual costs of similar elections was \$300.
