**AN ORDINANCE** to amend Ordinance No. 30,140 M.C.S., as amended, entitled “An Ordinance providing an Operating Budget of Expenditures for the City of New Orleans for the Year 2025” to appropriate a portion of the Savings Fund of the City of New Orleans—also known as the “Reserve Fund”—to the New Orleans Police Department to cover ongoing personnel expenses based on a determination by the Council that a significant loss in city revenues due to an economic downturn of serious proportions has occurred or is occurring; and otherwise to provide with respect thereto.

1           **SECTION 1. THE COUNCIL OF THE CITY OF NEW ORLEANS HEREBY**  
2 **ORDAINS**, That, in accordance with Section 6-201(2)(b)(ii)(B) of the Home Rule Charter, the  
3 Council, in adopting this Ordinance by a two-thirds vote of all of its members, does hereby determine  
4 that a significant loss in city revenues due to an economic downturn of serious proportions has  
5 occurred or is occurring, due in part to the unprecedented shutdown of the federal government and the  
6 concomitant disruption in federal reimbursements and funding, along with other factors.

1           **SECTION 2. THE COUNCIL OF THE CITY OF NEW ORLEANS HEREBY**  
2 **ORDAINS**, That, as a result of the determination reflected in Section 1, Ordinance No. 30,140  
3 M.C.S., as amended, be amended to authorize and direct the Director of Finance, notwithstanding any  
4 provision therein contained to the contrary, to transfer funds allocated therein as follows to effectuate  
5 an appropriation of \$25,000,000 from the Savings Fund of the City of New Orleans to the Department

6 of Police to cover payroll and personnel expenses:
