

**RESOLUTION**

A **RESOLUTION** calling an election in the Kenilworth Improvement District for November 3, 2026.

**WHEREAS**, the Louisiana State Legislature enacted La. R.S. 33:9078, creating the Kenilworth Improvement District (“District”) and authorizing the City Council of New Orleans to levy and collect an annual parcel fee not to exceed two hundred twenty-five dollars, for a term not to exceed eight years, when authorized by the District and approved by the majority of the District’s registered voters; and

**WHEREAS**, the Board of Commissioners of the District met on February 23, 2026, and adopted a resolution requesting the City Council of New Orleans to levy a \$225 parcel fee, for eight years, commencing on January 1, 2027 and ending December 31, 2034, subject to the majority approval of the District’s registered voters at the November 3, 2026 election; **NOW, THEREFORE**

**BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NEW ORLEANS**, That

**SECTION 1. Election Call.** Subject to the approval of the State Bond Commission and under the authority conferred by La. R.S. 33:9072 and the Louisiana Election Code (Title 18 of the Louisiana Revised Statutes of 1950, as amended), an election is hereby called for November 3, 2026 between the hours of 6:00 a.m. and 8:00 p.m. and at said election the electorate of the Kenilworth Improvement District may approve or disapprove the levy of an annual fee on each parcel located within the Kenilworth Improvement District (“District”), comprised of the area of the city of New Orleans bounded by: the mid-line of Morrison Road on the South, New Castle Street on the West, including

parcels on both sides of the street, Wales Street on the North, including parcels on both sides of the street that have municipal addresses on Wales Street, and the mid-line of Mayo Road on the East, in the amount of \$225, for eight years, beginning January 1, 2027 through December 31, 2034, which is estimated to generate \$143,500 annually. Any fee levied upon a parcel in the District shall be in addition to any ad valorem tax affecting real property, or any charge, (including, but not limited to, a sanitation charge), fee, license, permit or rate imposed or levied pursuant to the regulatory authority of the City of New Orleans in the operation of the city, its departments, agencies, boards and commissions, whether attached or unattached, including, but not limited to, the Sewerage & Water Board. The proceeds of any fee collected shall be used exclusively for the purpose of promoting and encouraging the beautification, security, and overall betterment of the District; however, the City of New Orleans may retain one percent of the amount collected as a collection fee. The affairs of the District shall be managed by the Board of Commissioners of the District. The Board shall adopt an annual budget in accordance with the Local Government Budget Act, La. R.S. 39:1301, et seq. The members of the Board shall serve without compensation.

The official ballot used in the voting machines for the election shall be as follows:

**KENILWORTH IMPROVEMENT DISTRICT PROPOSITION**

Shall the City of New Orleans levy an annual fee on each parcel located within the Kenilworth Improvement District (“District”), as delineated by La. R.S. 33:9078(C), in the amount of \$225, for eight years, beginning January 1, 2027 and ending December 31, 2034, which is estimated to generate \$143,500 annually, to be used exclusively for the purpose of promoting, encouraging, and enhancing the security, beautification, and overall betterment of the District, except a 1% City collection fee, and if used for additional law enforcement or security personnel and their services, such personnel and services shall be supplemental to and not in lieu those provided by the New Orleans Police Department?

**SECTION 2. District Boundaries.** The District is comprised of the area of the city of New Orleans bounded by: the mid-line of Morrison Road on the South, New Castle Street on the West, including parcels on both sides of the street, Wales Street on the North, including parcels on both sides of the street that have municipal addresses on Wales Street, and the mid-line of Mayo Road on the East.

**SECTION 3. Publication of Notice of Election.** Notice of this election shall be published in the City of New Orleans' official journal once a week for five consecutive weeks, with the first publication occurring between 45 and 90 days prior to the election date, as provided in Exhibit "A". Exhibit "A" is hereby incorporated as if the same were set forth in full.

**SECTION 4. Canvass.** The Council, acting under the powers granted to it by the City Charter and state statutes, shall meet, in open session, in the Council Chamber, City Hall, 1300 Perdido Street, New Orleans, Louisiana on Thursday, December 17, 2026, beginning at 10:00 a.m. to examine and canvass the returns and declare the election result.

**SECTION 5. Polling Places.** The polling places set forth in the aforesaid notice of election are hereby designated as the polling places at which to hold the said election, and the commissioners-in-charge and commissioners will be the same persons as those designated in accordance with law.

**SECTION 6. Election Commissioners; Voting Machines.** The officers designated to serve as commissioners-in-charge and commissioners pursuant to Section 5 hereof, or such substitutes therefor, as may be selected and designated in accordance with La. R.S. 18:1287, shall hold the said election as herein provided, and shall make due returns of said election to the City Council. All registered voters in the District are entitled to vote at said election and voting machines shall be used thereat.

**SECTION 7. Authorization of Officers.** The Clerk of Criminal District Court is hereby empowered, authorized and directed to arrange for and to furnish to said election officers in ample time for the holding of said election, the necessary equipment, forms and other paraphernalia essential to

the proper holding of said election and the President and/or Clerk of the City Council and the City Attorney are authorized, empowered and directed to take any and all further action required by state and/or federal law to arrange for the election.

**SECTION 8. Furnishing Election Call to Election Officials.** Certified copies of this resolution shall be forwarded to the Secretary of State, the Clerk of Court and ex-officio parish custodian of voting machines in and for the Parish of Orleans, State of Louisiana, and the Registrar of Voters in and for said parish, as notification of the election herein called, in order that each may prepare for said election and perform their respective functions as required by law.

**SECTION 9. Application to State Bond Commission.** Application is made to the State Bond Commission for consent and authority to hold the aforesaid election as herein provided, and in the event said election results in approval of the proposition, for further consent and authority to levy and collect the special fee provided for therein, and a certified copy of this resolution shall be forwarded to the State Bond Commission on behalf of the City Council requesting prompt consideration and approval of the application.

Pursuant to Resolution R-26-110, as adopted by the City Council of New Orleans on March 12, 2026, NOTICE IS HEREBY GIVEN, that an election will be held in New Orleans on November 3, 2026. The following proposition will be submitted to all registered voters (who are qualified and entitled to vote at this election in accordance with all state and federal laws) residing in the Kenilworth Improvement District (“District”), comprised of the area of the city of New Orleans bounded by: the mid-line of Morrison Road on the South, New Castle Street on the West, including parcels on both sides of the street, Wales Street on the North, including parcels on both sides of the street that have municipal addresses on Wales Street, and the mid-line of Mayo Road on the East:
