AN ORDINANCE to establish the Children’s Benevolence Fund as Division 55 of Article III in Chapter 70 of the Code of the City of New Orleans; to ordain Sections 70-415.344 through 70-415.349 of the Code of the City of New Orleans within said Division; and otherwise to provide with respect thereto.

SECTION 1. THE COUNCIL OF THE CITY OF NEW ORLEANS HEREBY

ORDAINS, That the Children’s Benevolence Fund be and hereby is established as Division 55 of Chapter 70, Article III of the Code of the City of New Orleans and that Sections 70-415.344 through 70-415.349 are ordained and established therein to read as follows:

“CHAPTER 70 - FINANCE

ARTICLE III. – FUN DS

* * *

DIVISION 55. Children’s Benevolence Fund

Sec. 70-415.344. – Fund Created.

There is hereby created a special fund designated as the Children’s Benevolence Fund (hereinafter “Fund”).

Sec. 70-415.345. – Purpose.

14 The Fund shall be used exclusively to provide financial assistance to the Orleans Parish School
15 Board and is intended both to resolve a dispute over the imposition of fees by the city in connection
16 with certain taxes on behalf of the Orleans Parish School Board and to promote the valuable public
17 purpose of ensuring continuity for vital services provided to children through the public schools.

18 **Sec. 70-415.346. – Funding Sources and Uses.**

19 The following amounts and funds shall be deposited annually by April 1 into the Fund, through
20 and including fiscal year 2034, and distributed annually to the Orleans Parish School Board:

21 (a) The full amount of all “School Support Payments” described in Section 4.5 of the Second
22 Amended and Restated Lease by and among the New Orleans Building Corporation, Jazz
23 Casino Company, L.L.C. and the city;

24 (b) A \$3 million appropriation from general revenue sources to fund the ThriveKids Student
25 Wellness Project or a comparable program dedicated to serving the mental-health needs of
26 students; and

27 (c) A \$1 million appropriation from general revenue sources to fund programming through
28 YouthForceNOLA, the New Orleans Career Center, or a comparable provider of vocational
29 and workforce development services.

30 **Sec. 70-415.347. – Restrictions on Fund.**

31 Funds deposited into the Fund shall remain in the Fund until transferred for the purposes specified
32 in section 70-415.346 and may not be transferred into the general fund or any other funds, except
33 as expressly authorized in this section. If the city and the Orleans Parish School Board are unable
34 to agree to a multi-year cooperative endeavor agreement memorializing the funding obligations
35 established herein, the funding may be authorized and allocated through a budget ordinance
36 authorizing an inter-governmental transfer.

37 **Sec. 70-415.348. – Required Reports and Participation Requirements.**

38 (a) The Director of Finance shall keep detailed and accurate records in the administration of
39 the Fund and shall make annual reports to the Chief Administrative Officer and City
40 Council, via the Clerk of Council, giving a complete and detailed written accounting of all
41 revenues in the Fund, and any expenditures made therefrom.

42 (b) To receive an appropriation as described herein, a representative of the Orleans Parish
43 School Board shall appear and present annually at the first scheduled budget hearing
44 conducted each year as part of the annual budget and as otherwise requested by the Council
45 or its committees.

46 **Sec. 70-415.349. – Administration of Fund.**

47 The Fund shall be administered by the Director of the Department of Finance and shall be kept in
48 an interest-bearing account, with interest accruing to the benefit of and to become part of the Fund.
