Pursuant to Chapter 154, Article XVII, Section 154-1705 of the City Code, please find attached the quarterly report for the second quarter of 2025 detailing the revenue generated by each automated traffic enforcement system device within the city, along with the corresponding costs associated with enforcement, administration, and related services. The report provides data on a monthly basis and includes a consolidated summary for the second quarter of 2025.

The report outlines each camera and its location, categorizes enforcement by school-zone and non-school-zone designations, and details associated costs, including vendor fees, administrative fees, and contributions to the Indigent Defender Fund. It also accounts for fees collected by the vendor when its subcontractor, Duncan Solutions, successfully recovers delinquent tickets over 60 days old. Additionally, the report summarizes net revenue for the reporting period.

To ensure transparency and ease of interpretation, the report includes two supplemental tabs: one containing raw data and another labeled "Data Notes," which provides explanatory context for the figures presented. The report has been prepared in accordance with all City Code requirements, including submission in spreadsheet format.
