The funds were included in the adopted budget but were inadvertently placed in the personnel category

rather than other operating. This ordinance corrects that classification so the funding can be used for its

Intended operational and programmatic purposes. The reallocation will support several NORDC

initiatives, including E-Sports and technology improvements, partnerships with InspireNOLA and

Spartan Boxing, security systems for seasonal pools, marketing services, and expanded programming
