This letter confirms the actions of the New Orleans Historic District Landmarks Commission at its meeting of Wednesday, April 8, 2026, concerning your application for the following work: Retention of the removal of ridge tiles at a Contributing rated, one-story, two-family residential building without a Certificate of Appropriateness.

At that time the Commission voted to:

Deny the application for retention of the removal of the ridge tiles. Replacement ridge tiles should be mounted to the existing asphalt shingle ridge caps.
