This letter confirms the actions of the New Orleans Historic District Landmarks Commission at its meeting Friday, October 17, 2025, concerning your application for the following work: Retention of two flush-mounted windows with half screens on both side elevations at a contributing rated one story, two-family residential building.

At that time the Commission voted to: Approval with the proviso that the existing windows be recessed and fitted with full screens to reduce the visibility of the internal muntins.
