**AN ORDINANCE** to effect a zoning change an HU-RM1 Historic Urban Multi-Family Residential District to an HU-MU Historic Urban Neighborhood Mixed-Use District and to establish a conditional use to permit the retail sale of packaged alcoholic beverages, on Square 259, Lots B and Pt. 10, in the Fourth Municipal District, bounded by Baronne Street, Washington Avenue, Dryades Street, and Fourth Street (Municipal Addresses: 2727-2733 Baronne Street); and otherwise to provide with respect thereto.

**WHEREAS, Zoning Docket Number 15/26** was initiated by Adams Baronne Property, LLC and referred to the City Planning Commission; and

**WHEREAS,** the City Planning Commission held a public hearing on this zoning petition and recommended approval of the requested zoning change and conditional use in its report to the City Council dated March 9, 2026, presented in **Zoning Docket Number 15/26**; and

**WHEREAS,** the recommendation of the City Planning Commission was upheld, the changes were deemed necessary and in the best interest of the City of New Orleans and the request was approved by the City Council, as stated in Motion Number M-26-135 of the Council of the City of New Orleans on March 26, 2026.

1           **SECTION 1. THE COUNCIL OF THE CITY OF NEW ORLEANS HEREBY**  
2   **ORDAINS,** That the Executive Director of the City Planning Commission be and is hereby

3 directed to change the appropriate zoning district maps together with all the notations, references,  
4 and other information shown thereon, together with the lot line zoning districts maps referred to  
5 in Ordinance No. 4264 M.C.S., as amended by Ordinance No. 26413 M.C.S., as amended, the  
6 Comprehensive Zoning Ordinance of the City of New Orleans, for a zoning change from an HU-  
7 RM1 Historic Urban Multi-Family Residential District to an HU-MU Historic Urban  
8 Neighborhood Mixed-Use District, on Square 259, Lots B and Pt. 10, in the Fourth Municipal  
9 District, bounded by Baronne Street, Washington Avenue, Dryades Street, and Fourth Street  
10 (Municipal Addresses: 2727-2733 Baronne Street); in accordance with Motion Number M-26-135  
11 of the Council of the City of New Orleans, approved on March 26, 2026.

1           **SECTION 2. THE COUNCIL OF THE CITY OF NEW ORLEANS HEREBY**  
2 **ORDAINS**, That a conditional use to permit the retail sale of packaged alcoholic beverages, on  
3 Square 259, Lots B and Pt. 10, in the Fourth Municipal District, bounded by Baronne Street,  
4 Washington Avenue, Dryades Street, and Fourth Street (Municipal Addresses: 2727-2733 Baronne  
5 Street); is hereby authorized and approved.

1           **SECTION 3.** This Ordinance shall have the legal force and effect of authorizing this  
2 conditional use after the City Planning Commission’s approval of the final site plan, which shall  
3 be submitted within one year of adoption of this Ordinance by the City Council, unless extended  
4 as authorized by the Comprehensive Zoning Ordinance. The Executive Director of the City  
5 Planning Commission shall sign the plan to indicate final plan approval. The final approved plan  
6 shall be recorded in the Office of the Clerk of Civil District Court for the Parish of Orleans, within  
7 30 days of the date of final approval, and evidence of such recordation shall be submitted to the  
8 City Planning Commission. No use or occupancy certificates or permits shall be issued until the  
9 final approved plan is recorded and evidence of recordation is submitted to the City Planning

10 Commission. If the development plan is not approved and recorded, within the timeframes  
11 provided in the Comprehensive Zoning Ordinance, then this Ordinance shall be null and void with  
12 no legal force or binding effect. Furthermore, if the requirements of Section 4.3.H.1 of the  
13 Comprehensive Zoning Ordinance are not satisfied within the timeframe allotted by Sections  
14 4.3.H.1 and 4.3.H.2 of the Comprehensive Zoning Ordinance, the conditional use will expire, and  
15 this Ordinance will be null and void. The preceding deadlines may be extended via motion in  
16 accordance with the Comprehensive Zoning Ordinance.
