AN ORDINANCE to effect a zoning map amendment from an OS-N Neighborhood Open Space District to an HU-RD-1 Historic Urban Two-Family Residential District, on Square 5, Lots B and C, Prosper Marigny Plantation, in the Fifth Municipal District, bounded by Lawrence Street, Pace Boulevard, Socrates Street, the Magellan Canal, and Morris F.X. Jeff Park (Municipal Address: 2701 Lawrence Street); and otherwise to provide with respect thereto.

WHEREAS, Zoning Docket Number 67/25 was initiated by Crescent City Schools Foundation Inc. and referred to the City Planning Commission; and

WHEREAS, the City Planning Commission held a public hearing on this zoning petition and recommended modified approval of the requested zoning change in its report to the City Council dated January 23, 2026, presented in **Zoning Docket Number 67/25**; and

WHEREAS, the recommendation of the City Planning Commission was upheld, and the changes were deemed necessary and in the best interest of the City of New Orleans and the request was approved in part and denied in part by the City Council, as stated in Motion Number M-26-78 of the Council of the City of New Orleans on February 26, 2026.

SECTION 1. THE COUNCIL OF THE CITY OF NEW ORLEANS HEREBY ORDAINS,

That the Executive Director of the City Planning Commission be and is hereby directed to change the appropriate zoning district maps together with all the notations, references, and other information shown thereon, together with the lot line zoning districts maps referred to in Ordinance No. 4264 M.C.S., as amended by Ordinance No. 26413 M.C.S., as amended, the Comprehensive Zoning Ordinance of the City of New Orleans, for a zoning change to effect a zoning change from an OS-N Neighborhood Open

7 Space District to an HU-RD-1 Historic Urban Two-Family Residential District, on Square 5, Lots B and
8 C, Prosper Marigny Plantation, in the Fifth Municipal District, bounded by Lawrence Street, Pace
9 Boulevard, Socrates Street, the Magellan Canal, and Morris F.X. Jeff Park (Municipal Address: 2701
10 Lawrence Street); in accordance with Motion Number M-26-78 of the Council of the City of New
11 Orleans, approved on February 26, 2026.

1 **SECTION 2.** Whoever does anything prohibited by this Ordinance or fails to do anything
2 required to be done by this Ordinance shall be guilty of a misdemeanor. Upon conviction of such a
3 misdemeanor, the individual shall be subject to a fine, imprisonment, or both, in accordance with Section
4 1-13 of the Code of the City of New Orleans. Such a conviction shall be cause for immediate cancellation
5 of the Use and Occupancy Permit for the premises. Alternatively, the individual shall be subject to
6 whatever civil liabilities, penalties, or remedies the law prescribes.
