**AN ORDINANCE** to temporarily waive certain fees, permit fees, and requirements within and around Hunter’s Field Playground located at 1659 North Claiborne Avenue, New Orleans, Louisiana in conjunction with the Social Aid & Pleasure Club Coalition Picnic event on Sunday, June 14, 2026 from 8:45 a.m. to 7:00 p.m., to specify the duration and boundaries of said waiver; and otherwise to provide with respect thereto.

1           **SECTION 1. THE COUNCIL OF THE CITY OF NEW ORLEANS HEREBY**  
2           **ORDAINS,** That the facility rental fee shall be waived for events and activities for the Social  
3           Aid & Pleasure Club Coalition Picnic event at Hunter’s Field Playground located at 1659 North  
4           Claiborne Avenue, scheduled for Sunday, June 14, 2026 from 8:45 a.m. to 7:00 p.m.. The fee  
5           waiver authorized by this section shall not include any direct costs to the City.

1           **SECTION 2.** That the provisions of Section 1 above shall apply only to those persons  
2           engaged in activities in conjunction with the Social Aid & Pleasure Club Coalition Picnic event,  
3           which shall be specified in writing, and the names of such persons shall be filed along with a  
4           schedule of approved activities by the authorized representative of the Social Aid & Pleasure  
5           Club Coalition Picnic event no later than ten days prior to the event

1           **SECTION 3.** That the authorized representative of the Social Aid & Pleasure Club  
2           Coalition Picnic event shall add the City of New Orleans as insured in the insurance policy held  
3           by the authorized representative of the Social Aid & Pleasure Club Coalition Picnic event for the

4 duration of its activities stated herein.

1           **SECTION 4.** That this ordinance shall be construed to supersede and waive the  
2 provisions of any moratorium or other ordinance that may be applicable.

1           **SECTION 5.** That in the event any of the above-referenced activities are postponed due  
2 to inclement weather or other circumstances beyond the control of the chairperson associated  
3 with the Social Aid & Pleasure Club Coalition Picnic event, the provisions for this ordinance  
4 may be applicable to any one or more of the rain dates specified by the authorized representative  
5 of the Social Aid & Pleasure Club Coalition Picnic event.
