**RESOLUTION AND ORDER ESTABLISHING PROCEDURAL SCHEDULE FOR
CONSIDERATION OF ENTERGY NEW ORLEANS, LLC'S RCPS COMPLIANCE
PLAN COVERING COMPLIANCE YEARS 2026-2028**

WHEREAS, pursuant to the Constitution of the State of Louisiana and the Home Rule Charter of the City of New Orleans (“Charter”), the Council of the City of New Orleans (“Council”) is the governmental body with the power of supervision, regulation, and control over public utilities providing service within the City of New Orleans; and

WHEREAS, pursuant to its powers of supervision, regulation and control over public utilities, the Council is responsible for fixing and changing rates and charges of public utilities, making all necessary rules and regulations governing the terms and conditions of service, applications for the fixing and changing of rates and charges of public utilities, and all other regulatory proceedings; and

WHEREAS, Entergy New Orleans, LLC (“ENO”) is a public utility providing electric service to all of New Orleans; and

WHEREAS, Section 4.e of the Renewable and Clean Portfolio Standard (“RCPS”) adopted by the Council in Resolution No. R-21-182 requires ENO to develop and submit for

Council approval, a three-year prospective RCPS Compliance Plan upon ENO's submission of its final Integrated Resource Plan ("IRP") for each triennial IRP cycle; and

WHEREAS, on December 13, 2024, ENO submitted its IRP to the Council in Docket No. UD-23-01; thereafter, on August 14, 2025, ENO submitted *Entergy New Orleans, LLC RCPS Compliance Plan Covering Compliance Years 2026-2028* ("RCPS Compliance Plan"); and

WHEREAS, the RCPS at Section 4.e states that there shall be the opportunity for stakeholder comment prior to the Council's review and approval of the RCPS Compliance Plan;

NOW THEREFORE

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NEW ORLEANS, That the following procedural schedule is adopted to consider the RCPS Compliance Plan:

1. Comments on the RCPS Compliance Plan shall be filed no later than Friday, October 10, 2025.

Comments should address the following:

- a. Whether the RCPS Compliance Plan is in compliance with the requirements of the RCPS.
2. Reply Comments shall be filed no later than Friday, October 24, 2025.
 3. An Advisors Report on the RCPS Compliance Plan shall be filed not later than Friday, November 21, 2025.
