Dear Green Flash II LLC:

This letter confirms the actions of the New Orleans Historic District Landmarks Commission at its meeting of Wednesday, April 8, 2026, concerning your application for the following work: Retention of the installation of inappropriate windows at a Contributing rated, two-story, two-family residential building without a Certificate of Appropriateness.

At that time the Commission voted to: Deny the application for retention of the of the installation of inappropriate windows on the left side due to their high visibility and because they do not match the original wood windows in profile, muntin pattern, or configuration.

The Commission did allow retention of the left side windows with the proviso that full screens are added, as they are the least visible from the public right-of-way.

Should you wish to appeal the Commission's decision to the City Council you must provide a written request for appeal to both the HDLC and the Clerk of Council, City Hall, Room 1E09, New Orleans, LA 70112 within ten (10) calendar days of the Commission meeting.
